

## LIVING ARRANGEMENTS FOR STUDENTS UNDER 18 YEARS OF AGE

This form is to be completed and signed by the parent or legal guardian of a student under the age of 18 intending to apply for a student visa to undertake study at CELUSA or SAIBT.

The Department of Immigration and Border Protection (DIBP) requires that living arrangements are approved by SAIBT / CELUSA for students who:

- are under the age of 18
- will accept an offer to study at CELUSA / SAIBT and
- will not be living with their parent / legal guardian, or nominated eligible relative over the age of 21 during their study at CELUSA / SAIBT.

Documentation required (Confirmation of Appropriate Accommodation and Welfare - CAAW) for a visa application will only be provided when this form is completed and returned to

- If DIBP has not approved Parent or Suitable Relative Guardianship three weeks before arriving in Australia, arrangements can be made for the student to stay in CELUSA / SAIBT approved accommodation for a minimum stay (5 weeks) and when approval is received, the student can then transfer to the nominated Guardian’s home.
- CELUSA / SAIBT may contact a parent / guardian, Homestay Hosts or Homeaway to discuss matters relating to student welfare.
