## **SECTION A - INTRODUCTION**

## A.1 Purpose

Navitas SA is committed to child safety and the provision of an environment where children are treated with respect and protected from harm. This policy outlines the standards of behaviour and practices that Navitas SA has implemented for staff working or volunteering with children.

It complies with the Child safe environments: Principles of good practice and Child safe environments: Standards for dealing with information obtained about the criminal history of employees and volunteers who work with children.

## A.2 Scope

This policy applies to the staff of the following colleges (collectively known as Navitas SA for the purpose of this policy):

- Educational Enterprises Australia Pty Ltd (EEA) trading as Eynesbury College, Eynesbury Institute of Business and Technology, Eynesbury College Academy of English, Eynesbury International
- South Australian Institute of Business and Technology Pty Ltd (SAIBT) trading as SAIBT, CELUSA being the Centre for English Language in the University of South Australia

## **SECTION B - POLICY STATEMENT**

## **B.1** Principles

All children who come to Navitas SA have a right to feel and be safe. Navitas SA is committed to the safety and well-being of all children and young people and the creation of a child safe and child friendly environment where all children are valued and feel safe.

## **B.2** Policy

#### 1 Children's participation

- **1.1** Navitas SA encourages and respects the views of children and young people. Navitas SA listens to and acts upon any concerns raised by children, young people or their families.
- **1.2** Navitas SA ensures that children, young people and their families know their rights and how to access the complaints procedures available to them.
- **1.3** Navitas SA values diversity and does not tolerate any discriminatory practices.

#### 2 Recruitment practices

- **2.1** Navitas SA takes all reasonable steps to ensure that it engages the most suitable and appropriate people to work with children. A range of measures are used in the screening and recruitment of employees and volunteers. Interviews and referee checks are conducted for all employees.
- **2.2** Child related employment screenings are undertaken by the DCSI screening unit for people working within our organisation that:
  - have regular contact with children and are not directly supervised at all times
  - work in close proximity to children on a regular basis and are not directly supervised at all times or
  - supervise or manage persons who:
    - have regular contact with children or
    - work in close proximity to children on a regular basis or
    - have access to sensitive records relating to children or young people

Exemptions from this requirement may apply and will be considered on a case-by-case basis.

#### 3 Code of conduct

- **3.1** All employees are made aware of, and must abide by, the **Navitas SA Code of Conduct**.
- **3.2** All students are made aware of, and must abide by, their relevant **Student Code of Conduct**.

#### 4 Support for employees and volunteers

**4.1** Navitas SA seeks to attract and retain the best employees and volunteers. We provide support and supervision so people feel valued, respected and fairly treated. We ensure that employees/volunteers who work with children have ongoing supervision, support and training so that their capacity is developed and enhanced to promote the establishment and maintenance of a child safe environment.

#### 5 Reporting and responding to suspected child abuse and neglect

5.1 Incidents of child abuse will not be tolerated. Please refer to the Navitas SA Mandatory Reporting Policy.

#### 6 Supporting children, young people and their families

- **6.1** Child Protection is everyone's responsibility. Even where a report is made, Navitas SA may still have a role in supporting the child or young person.
- **6.2** Support may include:
  - Referring the child, young person or their family to other appropriate services
  - Displaying information about services that can assist children and their families (such as the Kids Helpline and Youth Healthline) in areas accessed by children and their families.

#### 7 Strategies to manage risk

**7.1** To help maintain a safe environment for children, Navitas SA reviews its risks regularly and implements strategies to minimise and manage these risks.

#### 8 Harassment/bullying

8.1 Navitas SA opposes all forms of harassment, discrimination and bullying. Refer to the Navitas SA Staff Code of Conduct.

#### 9 Communication

**9.1** It is a requirement that all Navitas SA staff read and abide by this policy.
